


PLAN OF THE DAY-NOT TO BE REMOVED FROM THE SHIP!

1. From: CNO: Our country is engaged in a most significant national effort in support of the Republic of South Vietnam against the current aggression. In the US and abroad there are groups functioning under various slogans who are actively engaged in efforts to subvert the loyalty, allegiance and morale of the members of the US Armed Forces and to otherwise obstruct our military operations. There are also some bonafide pacifist groups in the US who are attempting to exercise their right to effect a change of government policy by constitutional means in winning over a majority of the electorate to the (sic) their view. Thus it is difficult for the average member of the Armed Forces to be able to distinguish between legitimate political minority group actions and subversive propaganda aimed at weakening the military effort. I am concerned lest naval personnel be duped by subversive groups taking advantage of this situation and be led to erroneous conclusions.

With respect to proper performance of the (sic) their military duties in accordance with their oath of office as members of the Armed Services of the United States, all hands are to be cautioned against improper influence by any of the various groups posing as peace advocates. Subversive groups are seeking defectors for propaganda purposes and really have no interest in the individual otherwise. The individual defector is abandoned when he loses his propaganda value.

An unauthorized absentee lets down his shipmates in any case, but defection to a foreign country is strong proof of the intent to desert. The statute of limitation is lifted so long as one remains outside US jurisdiction and whenever a defector returns to US soil he is liable for Court-Martial action as a deserter, with a maximum sentence of a Dishonorable Discharge and five year's imprisonment at hard labor. MC CARRAN ACT WITCH HUNT

NEW AMENDMENTS EXPOSED

(The following is a factsheet released by the National Mobilization Committee to End the War in Vietnam, about the new amendments to the Internal Security Act of 1950.)

1) The original McCarran Act, the Internal Security Act of 1950, was passed during the height of the McCarthy period over President Truman's veto.

2) President Truman in his veto message called it, 'the worst thought-control act since the Alien and Sedition Laws.'

3) Written into this law is the definition that there exists a world wide communist conspiracy with headquarters in Moscow, which used espionage sabotage, and terrorism to implement its totalitarian objectives.

4) The purpose of the new 'Dirksen Amendments' to the McCarran Act is to circumvent those portions of the old act (the registration, passport, and other provisions) declared unconstitutional by the Supreme Court of the United States.

5) The new law was rammed through Congress under a veil of secrecy and signed into law by President Johnson on Jan. 2, 1968. It was passed in the Senate by a vote of 3-2, with 95 Senators absent. It is aimed at suppressing the anti-war, black liberation, and other progressive movements.

6) Its provisions have been made so broad that practically any organization can be attacked. If there is but one communist in a 'position of influence,' in an organization, the Attorney General can move to have it register as a Communist Front.


7) The repressive powers of the Subversive Activities Control Board, created by the law are:

a. After conducting its 'hearing' the SACB automatically judges your organization and publishes its findings in a government register;

b. Persons or organizations found to be subversive must label all literature and solicitations whether by mail, radio, TV, or the phone: 'Distributed by (or solicited on behalf of)---, found by final order of the SACB to be a communist front organization;

c. Use of the 1st and 5th amendments at SACB hearings may be revoked-forcing individuals to testify against themselves and others under the alleged protection of 'Congressional immunity.'

d. It is a felony to disrupt in 'or near there as to obstruct' the hearings. Misbehavior is punishable by \$5,000 fine and one year imprisonment.



CHICANOS UNITE

The chicanos of California are uniting! A spirited organizational drive is planned from February 19 to 23. In January, 1968 Mexican-Americans representing most major California state colleges and universities met on the University of Southern California campus to establish a statewide movement of student Mexican-American organizations. The conference adhered to a policy of 'promoting the advancement in all the facets of his life of the chicano, a Mexican-American who is in the process of acculturation.'

Representatives from United Mexican-Americans (UMA), Young Chicanos for Community Action (YCCA), Mexican-American Youth Association (MAYA), demonstrated at the Memorial Coliseum in East Los Angeles against the inequities involved in the drafting of chicanos.

Relative statistics show that while 19% of all white anglo-saxon protestants eligible for service and 29% of all eligible Negroes are drafted, the Mexican-American stands a 45% chance of being invited into the armed services. Furthermore, while chicanos in their most concentrated areas the southwest ern states, constitutes only 10% of the population, 20% of all casualties in the Vietnam war are Mexican-American men.

Since the chicanos' draft status is directly related to his economic and educational situation, the conference prepared the following proposals which will be passed in about one month. Mexican-Americans:

- 1) denounce the American involvement in the Vietnam war as an immoral one, this war being fought by the minority poor;
 - 2) support the Black Olympic Games boycott;
 - 3) will boycott the merchants who exploit Mexican-American communities;
 - 4) demand that participation of the Mexican-Americans in the Educational Opportunity Program be apportioned in direct correlation to the population ratio in the community.

SD "WHITE POWER" NAZI

SAILOR HASSLED

CAPTAIN HALTS SHIPBOARD 'SUBVERSION'

(The following story is true, written by a sailor on a US Navy vessel which is home ported in San Diego. For obvious reasons TEASPOON is respecting this man's request to remain anonymous.)

During the latter part of December, 1967, I was fortunate enough to see our 'democracy' at work, firsthand, through the very people who are supposed to be defending it--the United States Navy.

I was at work at one of my assigned tasks on board when the messenger of the watch came from below on the quarter-deck and asked if he could have one of the Peace and Freedom Party pamphlets he had seen me with. It was for the petty officer of the watch.

I said no because I was busy and mainly because I had no particular urge for the petty officer to see one. This petty officer was narrow minded (and petty) and I knew that the contents of the pamphlet had little chance of reaching him. Besides, he was not a resident of California and could not register anyway.

Having his question answered the messenger left.

Ten minutes later he returned. This time he wanted a pamphlet for the CAPTAIN. I gave him the keys to my locker and told him to help himself.

Later, as I walked through the Officer's Country (the area where enlisted men are not allowed except to clean and perform janitor-

ial tasks) of my ship, I saw none other than the petty officer of the watch (whom I later tagged with the name 'Joe McCarthy.' He was standing in the passage way with the captain and the executive officer, holding one of my pamphlets.

As I walked by the stool pigeon he attempted to hide the pamphlet behind his back and threw a plastic smile at me.

'How are you?' he asked.

'Fine,' I said. 'Fine.'

It didn't take long for something to come of all this. In the latter part of the afternoon, I was paged over the PA system to come to the Officer's Stateroom.

As I was on my way I met the Exec. who said, 'Follow me.'

I dropped behind him and followed him. We passed the division officer and I asked him what I did.

'You fucked up,' he said.

I soon found myself in the Captain's cabin surrounded by my division officer, the exec., the captain, and the master-at-arms. ('Joe McCarthy' wasn't there, still on watch, I guessed. My pamphlet was in the captain's hand.

'What's this?' asked the captain.

'Peace and Freedom Party literature,' I said.

'What the hell are you doing handing them out on my ship?'

'I wasn't handing them out,' I said.

'Then how did I get this?' he asked.

'The petty officer of the watch got it at your request and gave it to you,' I answered.

At this he seemed disturbed, and he told me that the Navy was not a political organization, and that I better not hand out any more. Since I was outnumbered, I said that the Navy's status concerning politics was debatable.

The captain interrupted and said 'Get them off the ship--today! You may not like President Johnson but he's our Commander-in-Chief, and we do what he says no matter who he is.'

I guess Johnson is the closest thing to God in the Navy.

Our conversation ended after the captain told me I was free to do what I like on liberty, but I should 'keep my mouth shut' in the Navy. That struck me as very fair because he said he would treat anyone having Republican or Democratic literature the same way. I'll believe it when I see it.

The one thing that stuck most in my mind was the captain's statement that I was 'spreading hate and discontent.' How, I thought, can one spread hate and discontent in a Navy full of bigots and hypocrites?



BOMB WINS RESIGNATION

Mayor Curran finally met with BOMB last week. The meeting was called because, as reported in last week's TEASPOON, the mayor appointed Mr. Leon Williams as a youth co-ordinator without consulting the Southeast San Diego community. BOMB did not necessarily disagree with the mayor's choice for the position but rather his arbitrary method of selecting Williams.

After short and eloquent addresses by Frank Saiz and Joe Vinson, Mayor Curran suggested that he will accept Leon Williams resignation; that a meeting for the Council for Youth be called; that he will ask the Council for Youth to determine the criteria for selecting a co-ordinator; that the post be advertised; and that the Council for Youth would screen applicants and submit three names (or one, if they preferred) to him. The appointment would be made from this list and the Council for Youth would be an advisory group for the program.

The prevailing feeling was that there should be a separate group and that this group might have a couple of representatives on the Council for Youth. (The Council of Youth will be meeting this Friday to accept Leon William's resignation and to determine the job selection criteria.)

Just as an agreement was reached and everybody seemed happy with it, Julian Wise said, 'Now that the rain dance is all over, how am I guaranteed that another group won't come in next week also claiming that it needs a representative?' John Johnson of the Urban League then told the Mayor that he had been many times ill-advised by his advisors and suggested that he get a Mexican-American and a Black to advise him in these matters.

San Diego County has ignored the opportunity to initiate a Federal program that would alleviate some of San Diego's poverty.

The Federal Surplus Food Program allocates \$7 per month per person to individuals who are classified as 'poor.' The \$7 dollars provides a great deal of surplus food to these people.

'The time has come to take direct action against the Board,' said the Rev. Richard Schwitzgebel of Welfare Rights Organization.

Frank Saiz commented later, 'We have had two people here and they have been there for their own purposes and not for their community.' Mr. Saiz said further that Mr. Wise's 'rain dance' comment illustrates how out of touch the Mayor's office is.

Leon Williams had no comment about the meeting with the Mayor. He did say, however, that he was in favor of the existence of a combined community effort among the minority groups to solve their problems.

Frank Saiz said in conclusion, 'All the demands I think were met. The Citizens Interracial Committee is going to be responsible for contacting all the Black, Oriental and Mexican groups.'



HODGE FIRING QUESTIONED

Henry Hodge, manager of the San Diego Service Center, was dismissed in a surprise move by Stan Lena, Deputy Director of the Service Center in Sacramento. There was no official reason given for the dismissal.

The Service Centers, six in all, are set up by California to bring State and local government agencies that render service to the people in areas of densest poverty (ie, Oakland, Watts, and Southeast San Diego) under the co-ordination of one administrator. That administrator was, until last week, Henry Hodge.

Mr. Hodge described his job in this way, 'I was administrator for the Center and all the agencies (twenty altogether) in the Center came under my administration. Among the agencies are the State Department of Employment, State Department of Rehabilita-

tion, and the County Welfare Department (only in the Southeast S.D. area.)

When asked if he knew why he was dismissed he said he would not like to speculate at this time and added, 'I felt that progress had been and was being made.'

J.S. Calderas, assistant manager of the Service Center refused to comment. A civil servant at the Service Center said, 'I can't give any comment, and added with a knowing look in her eye, 'you know how the system is.'

'I'm very surprised to hear Henry's been terminated,' Bob Richards, Executive Director of the Leadership Training Program and a colleague of Mr. Hodge said. 'In my opinion he had been doing an excellent job as an administrator. Since he has been manager the agency has made considerable effort towards meeting the needs of the peo-

ple it serves. He has been very co-operative with other agencies. I am very concerned about the basis upon which the decision was made.'

Jack Katz, Executive Director of the Economic Opportunities Commission of San Diego, Inc., had this to say about the dismissal. 'Under the circumstances it raises a lot of questions in my mind. He has done a very good job in the Center. He has won the confidence of the community. As an individual I am writing to the Governor to reconsider as the decision was ill-advised and will be resented later by people with whom Mr. Hodge worked.'

Two days after the dismissal (and after it was mentioned in most of the mass media) TEASPOON asked the San Diego mayor, Frank Curran for his reaction. His answer: 'I don't know anything about it.'

STUDENTS FIGHT FOR LIFE

Dr. William C. Rust runs his own kingdom by the sea out on the end of Point Loma.

Sometimes known as United States International University and more familiarly known as California Western University which sometimes poses as an institute of higher education.

The image makers have cast Cal Western as a quiet, quasi-religious university offering 'whole-some living and a search for meaningful values in an atmosphere permeated with the great insights of our heritage.'

TEASPOON invaded the sanctity of Dr. Rust's kingdom this week to get the story from the people who are still writing it.

Students for New Politics, a semi-radical campus political front, has no leader. It is a seemingly undirected political power group which plans to use

any means within its grasp to force Dr. Rust to sign the Magna Carta.

(It should be noted that from an outside view 'any means' in Cal Western lingo doesn't include the use of force. Student leaders are still hesitant to use the term 'student power' and are almost afraid to be called activists.)

The number one man at Cal Western from the student viewpoint is former student president Yugi Mitani, who resigned a month ago.

'There's always been a kind of negative undertone to this campus,' Mitani said. 'They (the administration) make promises they never keep.'

'When I ran for president last spring I said I wanted the students to have something to say about what faculty members they had and what rules they lived by.'

One of the crucial, but overplayed issues locally

has been the campus policy on alcoholic beverages.

Until Mitani's recent campaigns on this issue Cal Western students were not supposed to drink--on or OFF campus.

Student leaders tell of one honor student who was expelled for a minor violation of this policy, was drafted and killed in Vietnam--a stiff penalty for one drink.

There are three bureaucrats involved in the Cal Western picture.

On top is Dr. Rust, who, with automatic approval of a puppet board of trustees, is the total dictator for the campus.

Reports of Dr. Rust's power include his high-handed rule making and his personal interference with the hiring and firing of faculty. Supporting Dr. Rust is Dr. R. Carroll Cannon, provost of the CW campus.

Dr. Cannon has told students that 'The basic poli-

cies of this institution can never be changed or this would be a different institution.'

Dr. William E. Clarke, dean of students, has said that 'The use of alcoholic beverages is a detriment to society.'

Students and faculty alike complain of Dr. Rust's kindly attitude, specifically in line with his views that Cal Western should be a tailor-made institution; those students and faculty who won't fit should get out and go elsewhere.

There are rumors about that numerous students will be booted off campus on such idle charges as having 'challenged the roots of the university.'

Campus activists, such as Mitani, Miss Zacchino and New Politics' unofficial leader Jim Hirst stand to lose a great deal if the students lose their battle.



RIGHT IS OUT AT GROSSMONT J.C.

Communism threatens the moral fiber of Grossmont College.

'I don't want to see commie kooks appearing on our campus,' said Mr. William Dawsey would-be chief patriot who recently lost an El Cajon election to the Grossmont College Board of Trustees.

It is curious that Dawsey lost. Grossmont appears to have been traditionally a bastion of anti-communism.

Since Ben Dobbs of the Communist Party, USA, appeared in a panel discussion three years ago at Grossmont, the 'ideological shit' has been splattering all over the fan.

An impressive string of radical speakers have been denied access to the campus ranging from nationally known CPers to the now defunct George Lincoln Rockwell.

By threatening the withholding of school bonds,

rightist factions in El Cajon have coerced the Board of Trustees of the college to deny this access to 'un-American' speakers.

But now it seems that the tables might be turning. Grossmonts Faculty Senate has invited the American Civil Liberties Union to discuss suing the Trustees if a forthcoming decision is against allowing these controversialists to speak, according to Grossmont Counselor John Feare.

A recent poll conducted among Grossmont students indicated that the concensus was with allowing the Communists to speak, according to Ernest Ewin, former commissioner of elections.

While Dawsey said that he and his rightist views represent the community at large, it is interesting to note that he lost in the Trustee election and the two pro-controversial trustees were re-elected.

BIG BROTHER WAS HERE IN MORE THAN ONE WAY

Big Brother and Her Hold-Company came through last Saturday at the Concourse with testimony to the continuing beauty of Hard Rock Power. This was their last performance on the West Coast prior to eastern engagements and it was a pity that the conditions provided by the city, for the performance were so poor.

The treatment of the paying public was incredible. The sexes were told to separate and enter in

8) 'Detention camps, created by Title II of the old act, are still in effect and may be used for 'subversives in the event that the President declares a state of emergency.' Five such camps around the country have been recently renovated.

9) A SACB 'hearing' is not a trial. It is an attempt to 'expose' and destroy an organization by giving it enormous adverse publicity, harrassing its members and bogging it down in prolonged legal battles and huge expenditures. The bulk of the testimony presented comes from paid stool pigeons, FBI agents, and other low-life informers and the verdict is handed down by 5 bureaucrats receiving \$26,000 a year for their efforts.

10) A facade of judicial process is presented, but the verdict of guilty is

built into the law. The new amendment stipulates that the SACB must conduct new hearings by the end of 1968 or go out of business.

The SACB's first intended victim is the W. E. B. Du Bois Clubs of America. On February 27, hearings will begin in New York allegedly to determine whether or not the Du Bois Clubs are a 'communist front' group.

If the government succeeds in destroying this group, the SACB, the Senate Internal Security Sub-Committee, and HUAC will feel free to move into a general assault on all groups working for freedom, peace, and social progress. It is important to understand that during the debate on the McCarran Act Amendments in Congress last fall, supporters of the bill claimed that if passed it could be used to destroy over 200 peace and freedom organizations.

LEADERSHIP TRAINING CLIPPED BY STATE

Because San Diego has not bothered to achieve 'model city' status, she is beginning to lose much-needed poverty funds. One of the first projects that may fall under the federal axe is Self-Help Through Neighborhood Leadership, Inc.

S-HTNL developed and implemented a New Careers Program in August, 1967. On October 27, 1967 the Economic Opportunity Commission of San Diego County was informed in writing by the Bureau of Work Training Programs that the allocations for New Careers Programs in San Diego County was \$162,230. On January 11, 1968 the ECC was informed by the regional office of BWTP that only 50 New Careers Programs would be funded throughout the country.

On January 17, 1968 Leadership training was informed that no funds would be available for a New Careers project in San Diego as all New Careers funds would be given only to cities designated as 'model cities' by the Department of Housing and Urban Development.

For a city to become a model city it must demonstrate to the federal government that it is concerned with poverty problems. Among the ways this is done is by drawing up a long-range progress guide called a general plan for the city.

This was done, and passed by the voters of San Diego several months ago. San Diego is still not a 'model city.' There are two reasons for this. First, the application is a very complicated process. According to Principle Planner David Smith, of the Cities General Planning Office, 'It would take about 6 months to apply to become a model city. The real hang-up is the length of time the Department of Housing and Urban development takes in evaluating the application.'

The second reason San Diego isn't a model city is because even though the general plan passed over three months ago the city has not even applied yet! Smith said that the planning office in conjunction with the city manager could probably make the application but the say, as to precisely who and how, is up to the council. 'Our council hasn't seen fit make such authorization. We can't do anything until we have been directed to do so,' said Smith who appeared well-

prepared and impatient to get going on the application.

Self-Help Through Neighborhood Leadership, Inc. operates a careers project which trains 35 low income, disadvantaged persons for sub-professional jobs in teaching, social work, and corrections. In addition it has other auxiliary projects meeting community needs, one of which is Teen Post # 1 that includes 350 hard core, poor, multiproblem minority group youths aged 13 to 20 years.

The project complements other programs in the area by:

- 1) maintaining communications between the minority and majority communities;
- 2) motivating the hopeless to compete in the labor market;
- 3) helping deprived persons to achieve their attainable aspirations;
- 4) restoring pride and dignity to the disadvantaged poor;
- 5) removing bitterness by directing individual efforts toward constructive action the direction of self and community betterment;
- 6) developing employable skills among the chronically deprived.

'To withdraw financial support from the project would jeopardize the faith and confidence in government perhaps for all time of all needy people in San Diego,' Director of Self-Help Through Neighborhood Leadership, Bob Richards warned, 'Are these people being discriminated against because there have been no riots in San Diego? This situation has implications for complete disillusionment and unrest in Southeast San Diego. It raises serious questions as to the sincerity and commitment of Federal Agencies to develop and maintain man power training opportunities for the poor. Man power development programs are the highest priority of all programs to help the poor in the USA. If the government is not concerned with poverty problems they should do nothing and not pay lip service and emasculate needed projects' (Editor's note: Bob Richards is researching other methods of funding and strongly suggests that you register strong protests with those involved including LBJ, Secretary of Labor Willard Wirtz, Economic Opportunity Director Sargent Xhriver.)

TOOTHBRUSHES AND NAPALM

NET once again came fields through last Wednesday when it presented a documentary and debate concerning the reality of North Vietnam.

The documentary was obviously an experience and was intended to relay the conditions found in the North to any that would watch and listen. The following debate involved David Schoenbrun from Columbia and Robert Scallapino a political science prof. from Berkeley who is widely known for his academic achievements in Chinese history. Schoenbrun had been to North Vietnam many times and was definitely in rapport with Felix Green's efforts. Scallapino, however seemed to be confident that his academic familiarization with the conditions portrayed in the film qualified his critical attitudes. In short, Schoenbrun showed Scallapino as a government apologist and that's all there was to it.

Viewed by an unseen and uncounted audience which is just now becoming aware that it is living in a police state, this piece frankly points to the degree of internal harmony the Vietnamese experience with their government, poignantly exhibited by the enthusiasm of all who are capable of bearing arms.

It would be tragically unfortunate to cite this as a prime example of national unity for any nation, for any purpose, for any 'foe', but when the prime resource of a country is its people, the people must do the job.

The documentary openly admitting its bias toward the Vietnamese's personal situation, clearly pointed to the fact that the people are doing just that: fighting if needed, hiding when needed, rebuilding when needed.

No artificial preoccupations are needed in the villages or hamlets to satisfy the youth. They are bluntly asked to severely limit their personal emotions in favor of total involvement within the Hell they are caught up in.

The documentary (originally sponsored by CBS but later ignored by them when it was reviewed for release...no concrete explanation given) was rightfully sympathetic to the point of tears.

It showed hundreds of youths banding together, rebuilding the routes which we destroy--it was the first real love-in I've experienced; a bed-ridden American flyer testified concerning the humane treatment he'd received after capture--a situation experienced by many fighters downed while flying low enough to pick up the peasants working in the rice

LeROI JONES GETS 3 YEARS

LeRoi Jones, Black playwright, poet, and essayist, was sentenced to two and a half years in jail and a \$1000 fine. The Jan. 4 conviction was on charges of 'illegal possession of weapons' during the outbreak of rebellion in the Newark ghetto last summer. The sentence was almost the maximum possible (three years is the most he could have gotten) and it was stipulated that probation would not be allowed.

LeRoi Jones gave this account of the circumstances leading to his arrest:

'After midnight on July 14, 1967, I and my companions were driving in my station wagon, talking and listening to the radio. As we reached the corner of South Orange Ave., which was on our direct route home, we were stopped by at least two carloads of white helmeted police with shotguns, and several detectives.

'We were told to come out of the car. When I opened the door and stepped down, one detective reached up to me, screaming that we were 'the bastards' who'd been shooting at them. Whereupon he hit me in the face and threw me up against the side of the truck.

'The detective then began to jab me as hard as he could with his pistol in my stomach, asking, 'Where were the guns?' I told him there were no guns. Suddenly it seemed to me that five or six officers surrounded me and began to beat me. One officer tried to kick me in the groin, and there were many punches thrown. As they beat they kept calling us animals.

'They took us from the wagon and as I was pushed up the stairs at police headquarters an officer called out, 'Wait a minute' and then punched me in the pit of my stomach. I fell to the ground.

'Inside the station the police director was standing behind the desk. I asked him had he ordered me beaten. He replied, 'They got you, didn't they?'--smiling.'

During the trial, eye witnesses of the beating testified in defense of Jones, but police denied the beating.

At the final court session, the judge admitted that the severity of the sentence was based on his dislike of Jones's political viewpoint as expressed in a poem published in EVER-GREEN REVIEW. Judge Kapp

even went so far as to read the poem aloud before the court. He said the poem was a 'diabolical prescription to commit murder and to steal and loot.'

After the judge pronounced the official verdict 'You are sentenced on the unlawful possession of two revolvers...' Jones added 'And two poems!'

MOVIE REVIEW

"THE STRANGER"

Luchino Visconti was just another one of those recalcitrant young men who, rebelling against his family, became the champion of a class of people completely alien to his background. This Italian neorealist director did an about-face from his family of wealthy Milanese dukes, politically powerful since the Renaissance, to the Marxist-Leninist groups who were trying to hold their own when Italy was controlled by a fascist dictator.

Visconti became an outspoken Marxist and used part of the fortune which he inherited from his aristocratic family to produce films in which he interpreted characters in terms of their class (according to Marxist tradition). During the 1940's Italy's fascist military actually surveyed his work as he was directing, changing the lines and the plot whenever they didn't comply with the fascist tradition. This was an especially frustrating restriction for a director of the Italian neorealist school, which is more concerned with content and social applicability than with artistic effects.

The influence of the neorealist ideal is quite evident in Visconti's most recent film *The Stranger*, an interpretation of the novel by Albert Camus. The film follows Camus' story and emotional content faithfully with its theme of the absurdity of man's undignified and aimless existence. True to the neorealist tradition, Visconti has used no unusual effects (as one might have expected had Alain Resnais directed the film); he follows strict narrative form, varying from Camus only in his rapid cuts from one scene to another.

In comparison to Camus' character, Marcello Mastroianni's Meursault is rather sweet. Perhaps it is because of his angelic face, or his laughing, shuddering uncertainty when he replies, 'No, no, no,' to his mistress when she tells him marriage is a serious matter. Camus had used only one quite definite 'No.' Despite this, most of Mastroianni's scenes are credible interpretations of an Algerian who in the broiling heat of the sun unintentionally murdered an Arab. In the mock-dignity of the courtroom Meursault learns that his inability to feel emotionally involved with man's absurd birth-death cycle is far more instrumental than his murder of the Arab in procuring for him the death sentence.



Teaspoon Editors:

Regarding your editorial of February 8 criticizing the Peace and Freedom Party for not supporting Ashton Jones.

On the basis of a careful investigation made by myself and Jeff Siegal which involved interviewing Mr. Jones, Mr. Bill Griffith, and Mr. Hawkins, the manager of the apartments from which Mr. Jones was evicted, we came to the following conclusions:

A. Mr. Jones was not evicted because of any activity concerning the Peace and Freedom Party. Mr. Jones was evicted because of complaints made against his dog. In support of this we have Mr. Hawkins' word that five other tenants were evicted from the same apartments in the last 60 days because of complaints about their pets. Mr. Hawkins said that Mr. Jones could have stayed in the apartments if he were to give up his pet. We do not understand why Mr. Jones did not call Mr. Hawkins' bluff if indeed Mr. Hawkins were lying.

B. Mr Hawkins claims that he had no objection to Mr. Jones passing out Peace and Freedom literature in the mailboxes of the residents of the Penasquitos Village apartments. He did ask Mr. Jones not to personally ring doorbells of the residents, but he did this only after receiving complaints about Mr. Jones. We generally instructed our registration workers not to impose themselves on people who were hostile or unwilling to listen to rational arguments.

C. On the alleged personal attack made by Mr.

The Johnson Administration has entered another round of the 'Big Lie' game. The American public has been fed so many White House fabrications in the past few years (the U-2 that strayed into Russian skies, the bombing of Havana by 'rebel Cuban planes' just before the CIA sponsored an invasion of Cuba, the Marines sent to Santo Domingo 'to rescue civilians, and the Tonkin Gulf fabrications) that on the Pueblo incident we believe the North Koreans.

Johnson used the Gulf of Tonkin developments as a pretext for putting into action planes for bombing North Vietnam. Just last year, Fulbright finally exposed the distortions in that crisis. He stated that the two destroyers that had been 'attacked' were engaged in spying on North Vietnam and suggested that the question of whether or not they were in North Vietnamese waters was still open.

The Pueblo events parallel the circumstances surrounding the Gulf of Tonkin. In the six crewmen's confessions released by the North

Koreans, they said that the Pueblo had on at least four occasions penetrated the territorial waters of North Korea. Its navigator and executive officer Lt. Edward R. Murphy, was quoted as saying that the ship was within 7.6 miles of North Korea's Yo island when it was seized.

True to its usual form the United States Government's official position has changed many times. Johnson immediately became defensive, produced reams of maps and diagrams to prove 'conclusively' that the Pueblo was 'at least' 25 miles from the Korean coastline. Then a week later, McNamara and Rusk blew the scene when they said that they could not be certain until the crewmen were returned and questioned.

It is not difficult to understand why with all of these contradictions, students and various other segments of the population continuously question Johnson and his ambivalent Cabinet. It seems likely that with Johnson's record very little of what he says in the future will be believed.

In summary, then, we of the Peace and Freedom Party did not support a demonstration protesting Mr. Jones' eviction because we could find no evidence that his eviction had anything to do with activities even remotely connected with the Peace and Freedom Party.

Like many other corporate giants, Dow demonstrates the increasing dependence of Big Business for profits from military contracts and foreign investments. In fact, as a part of the total profits these two sources provide as much as 50% or more of the earnings of a growing number of key corporations in the economy. As representatives of many of these giants, some 45 individuals pledged complete support to Johnson's Vietnam policies (New York Times, September 9, 1966).

These are the same industrialists and bankers that joined hands with the large German trust and cartels that used Hitler to brutally accumulate and consolidate control over the peoples and resources of most of Europe.

Attesting to the present existence of these same old relationships is Dow Chemical. On April 6, 1965, the Badische Anilin and Soda Fabrik--largest chemical company in West Germany--celebrated its 100th birthday. Its chairman is Carl Wurster, a former chairman of I.G. Farben--a huge chemical trust that was formed during the Nazi period and which was a mainstay of the Third Reich. During this period, Mr. Wurster was not only chairman of Badische--a member of I.G. Farben, but he also ran the I.G. Farben division which included the slave labor synthetic rubber plant at Auschwitz.

The I.G. Farben owned 42.5% of a retail and wholesale distributor called Degesch. Wurster It was the I.G. Farben researchers who developed the Zyklon B gas used to slaughter Jews in the concentration camps. Degesch was the firm which sold the gas to the camp at Auschwitz.

Today, Wurster's firm, the Badische Anilin Soda Fabrik, owns several American subsidiaries among them Computron, Inc. Furthermore, Wurster's company is in partnership with the Dow Chemical Corp. in a chemical company in Freeport, Texas called the Dow Badische Chemical Co..

For these reasons, members of SdS will protest the function of this university in permitting a criminal organization to recruit on this campus. In doing so, we are acting in the best interest of our fellow students and Americans. Sds sees this as just one more way the University helps the government prosecute its unjust war in Vietnam, a war against the best interests of the Vietnamese people and the American people, including students. We encourage our fellow students and faculty to join with us in protest today, Wednesday, Feb. 14.
