'Spaghetti Feed' Will Honor Team

The Alumni Association will honor **Coach Bill Terry** and members of the Aztec football squad at a pre-season "spaghetti feed" and "get acquainted" party Friday, Sept. 20, at 6:30 p.m. in the men's gym.

Bob Breitbard, Alumni vice-president and chairman of the athletic committee, is in charge of arrangements and announces that the program will include Terry, who will introduce his squad and discuss season prospects, and Mike Pecarovich and Bob Ripley, coach and general manager, respectively, of the San Diego Bombers.

"All Alumni members are invited," Breitbard said, "and we want to see a big turnout to show Terry and his boys that the Alumni Association is behind them."

The party comes just eight days before the Aztecs open their season's schedule against Pomona College Saturday, Sept. 28, in Balboa stadium. In addition to the speakers, an entertainment program is planned, Breitbard said.

The "spaghetti feed" replaces an Alumni beach party which had originally been scheduled for Sept. 15. The latter event was cancelled by the Board of Directors.

All Alumni planning to attend are requested to make reservations with Breitbard, **Barney Carman**, in the Graduate Manager's office, or the Executive Secretary's office.

Homecoming Dance

The Alumni Homecoming Dinner Dance will be held Friday, Nov. I, in Balboa Park. For details, turn to page 2. Bob Breitbard '41, currently serving as first vice-president of the Alumni Association, tops the ticket selected by the Nominating Committee for the October election of Association officers and members of the Board of Directors. Breitbard, who has actively promoted and supported all Alumni affairs since the reorganization last November, is the committee's nominee for President for 1947.

Also nominated by the committee were candidates for First and Second Vice-Presidents, Corresponding Secretary and 10 members of the Board of Directors. One-half of the present Board will continue to serve during 1947, and the 10 to be elected will serve for two years.

Although the constitution does not require that nominees' names be published before the October issue of the Alumni News, a week prior to the mailing of ballots, the Nominating Committee felt that its selections should be presented now in order to give the membership-at-large sufficient time to put other candidates on the ballot by petition if desired.

The constitution provides that any eligible member (i.e., paid up) may be placed on the ballot by means of a petition signed by 25 paid up members. Petitions must be in the Executive Secretary's office by the end of the third week in September.



Alumni Scholarship Campaign Begins

The first major project of the Alumni Association on behalf of San Diego State College—a campaign to establish a \$25,000 Athletic Scholarship Fund —got under way in mid-August after several months of preliminary preparation.

Sponsored and directed by the Alumni Association and enjoying the support and endorsement of a number of civic leaders, the campaign has as its goal the setting up of a \$25,000 fund which, once established, will become self-perpetuating.

Dr. David Jessop '34 is chairman of the committee of Alumni and friends of the college which is in charge of the campaign.

Funds realized by the campaign will be turned over to the San Diego State College Foundation Fund, non-profit corporation which receives and administers all scholarship and loan funds for the college.

Candidates for scholarships will be recommended by the Director of Athletics to the Scholarships and Loans committee of the college faculty, and all candidates approved for scholarships must meet the admission standards of the college and the eligibility requirements of the California Collegiate Athletic Association.

tention of civic leaders, Dr. Jessop issued the following statement:

"The Alumni Association has but one basic objective in sponsoring the San Diego State College Athletic Scholarship Campaign: To aid San Diego State College in providing an education for as many students as possible and to assist in making State College a school which, in years to come, will continue to develop its reputation as one of the west's best educational institutions.

"The Alumni Association recognizes that successful athletics constitute a means to an end. They afford stimulation of a worth-while competitive spirit on the part of students and alumni alike, develop a wholesome pride in their

school and, of primary importance, afford one of the means by which a college can further develop its educational program."

Scholarships wil be awarded on the basis of need and will cover only tuition and/or board and room expenses for needy students during the period they are competing on athletic teams. This will allow for athletic participation on the part of many students who otherwise would be deprived of the opportunity because of the economic necessity of holding jobs after school hours.

Once established, the scholarship fund will be perpetuated partly through interest on invested capital and partly through diversion of a percentage of

S. D. State Grows!

Off-campus housing units for the exclusive use of Aztec veterans . . .

That's the vastly changed State College that Aztecs will come back to when registration begins Monday, Sept. 16.

Enrollment, boosted by a tremendous influx of veterans taking advantage of the G.I. Bill, wil come within a few hundred of doubling the previous highest enrollment in the college's history. Nearly two-thirds of the enrollment will be veterans, according to the estimate of **Dr. Alfred White**, registrar.

In order to meet the requirements of the suddenly-increased student body, the college administration will schedule classes throughout the day until 6.00 p.m. In several instances classes will be scheduled in the evening, and other classes will meet Saturday mornings.

Construction is now under way on 23 temporary campus buildings, including a large Quonset hut on the quad which will house an additional study hall. Faculty offices and class rooms will be housed in eight other steel buildings on the quad and the former parking lot to the west.

The book store will be moved into a new building being erected on the small parking lot adjacent to the training school field, and the present book store will house student body offices.

Four hundred housing units for the exclusive use of Aztec veterans are being readied at the Riverlawn and Frontier housing projects near the lower end of Mission Valley, and from 150 to 200 units are supposed to be ready for occupancy by Sept. 15. The others should be ready in November.

Married veterans will be given preference in obtaining these units. Applications should be submitted to **Miss Kath**erine Pyle in the Veterans' office.

All this is temporary.

When priorities and material become available, construction will begin on more than a million and a half dollars worth of permanent improvements, including dormitories, as outlined by **Pres. Walter R. Hepner** in his enlightening article in the May issue of the Aztec Alumni News Letter.

Dating back to the days when State was just a normal school, Ethel E. Peterson, wife of our own Dean C. E., got her certificate from State in '17 after having studied at the U. of Oregon. Mrs. Peterson was already married when she came to San Diego in '14. She was a member of the Dogwatch rowing group, one of the two crews that took the place of sororities. Mrs. Peterson taught at La Jolla High School for four years, has been at Hoover the rest of her teaching career, in the Latin department. Her son, Bob, who was wellknown on campus, was killed in Belgium in '45. A daughter, Marian, now Mrs.

J. H. Williams, has two young sons. Another member of the class of '17 is Eugenia M. Welker, who has taught everything from typing and reading to physical ed in the local schools. Miss Welker edited the "Normal News," was a member of the Philomel chorus, belonged to a rowing crew, was a member of the cast of "Admetus," written by Irving Outcalt and presented yearly by the school, and helped start the Quiensabe club, a social group for older students. She received her degree in '24, the first class ever to graduate in caps and gowns, hence called themselves the Cap and Gown club. Miss Welker was awarded a fellowship from the Commonwealth fund to the New York school of social work, used this training to work three years as a visiting teacher doing psychiatric social work. She now teaches in the English department at Hoover.

Ethel L. Henderson, of the social studies dept., also was with the class of '17, taught for a while at Emerson, then went to Berkeley for a degree in '23, took her M.A. from there in '31. Since then she has been at Pt. Loma High and Hoover, was for 15 years a Camp Fire Guardian with the Pt. Loma group.

Dan Showley, who teaches Spanish, was a member of the class of '35, was in Tau Sigma, took a year of graduate work at Berkeley the following year. Having served with the navy for three and a half years in the communications branch, he was separated in Dec. '45 from the service, has just returned from a month's trip to Mexico. 




